Reference to the invited tender under No. 27980 under Single Stage one Envelop Bidding Procedure for the supply of Tyres (Re-tender) Package "A" and Printing and Stationery Items, Package "B" to Women University, Swabi. Tender No.WUS/Proc/2025/3 the bid evaluation for Package B completed and uploaded on University and Authority Websites. While for Package "A" i-e supply of Tyres (Retender) the given below firms/Bidders applied for the tender.

After detail checking of the basic eligibility of the firm's /bidders mentioned in the tender documents for tender No.WUS/Proc/2025/3.The Committee recommended that the below firm/Bidder considered ineligible.

2	Zareen Traders	a. Ineligible for (Package A) of the tender document i-e tyres. Zareen traders completed only one similar assignment in the last two years. As per tender document the required qualification of bidders were that the bidder must completed two similar assignments in the last two years. b. Tender Processing fee not submitted by the bidder.

As per 103<sup>rd</sup> meeting of the Central Purchase Committee the Committee recommended that single bidder is eligible for **Package-B** of the tender i-e supply of tyres. The Committee recommended market survey for the quoted rate of tyres by the Single bidder i-e Trade Man.

KP-PPRA rules in case of single bidder.

**KP-PPRA amended rules 2014 dated 17-08-2022 for a single bidder is reproduced below;**

**[“6A. Single bid in goods. ---** The single bid in goods may be considered if it meets the evaluation criteria expressed in advertisement or bid solicitation documents and is not in conflict with the Act, these rules, regulations or policy of Government, for the time being in force. The single bid shall be in conformity with best evaluated bid. The procuring entity shall make a decision with due diligence and in light of section 3 of the Act.”.]16

As per Market Survey three quotations received from three different tyres suppliers. The quoted rates which were received through market survey were compared with the quoted rate of the Single bidder i-e Trade Man as per following detail.


